Summary Paragraph

Lincoln Beach is an 17-acre waterfront park and 10-acre beach parking area located in New Orleans East along the south shore of Lake Pontchartrain in the Little Woods neighborhood. The site's entrance is designated by two significant metal marquee signs and a significant concrete pedestrian tunnel constructed in 1939 for the purposes of providing access to the man-made beach. Concrete pedestrian pathways lead in either direction to reconnect at a central promenade that runs across the site in an east-west orientation. At each end of the promenade are significant Moderne concrete pavilions that date to the 1952 improvements made by architect August Perez, Jr. Beyond the promenade and pavilions, sandy pathways lead to the shore of the beach. From the beach, a concrete waterfront structure can be accessed, also dating to the 1950s, from the former Nolan McNeill swimming pools. Though the site has lost a considerable amount of architectural fabric over time due to natural disasters and selective demolition of the former amusement park's amenities, a high level of historic integrity is present in the site's location, setting, feeling, and association. All of the remaining contributing structures have a significant and recognizable degree of integrity in their location, association, material, design, and workmanship.

Narrative Description

In 1938, Samuel Zemurray of the United Fruit Company deeded a parcel of land to the City of New Orleans. The New Orleans Levee Board purchased the land from the city in 1939 and designated the area as an approved swimming area for African American residents. In partnership with the New Orleans and North Eastern Railroad, a pedestrian tunnel was built beneath the main railway tracks, connecting New Orleans to Meridian, Mississippi. In 1941, the WPA expanded the site of the "Negro Beach" to 10 acres and made improvements to the site which included a shell parking lot, a manmade sand beach, a bath house on the beach, and three stone breakwater structures.

In 1951, New Orleans mayor Chep Morrison decided to upgrade the facilities. The site expanded to 17 acres, and the beach was filled in with new sand. However, the lake water at the site was polluted due to the disposal of waste by nearby fishing camps, so other plans had to be made for safe swimming. In 1953, Architect August Perez Jr. was commissioned to design the architectural

improvements. Plans for the beach included the construction of three swimming pools named in honor of Nolan McNeill, converting the old WPA bathhouse into a restaurant (namely, the Carver House Restaurant), the design and construction of two new bath houses (which are the pavilions currently on the site), and planning for an amusement park with rides and several attractions. A parking lot was located across the street with two metal marquee signs pointing visitors to the beach entrance. Morrison named the new development "Lincoln Beach" after Abraham Lincoln. On May 8, 1954, a dedication ceremony was held to celebrate the opening of Lincoln Beach.

Lincoln Beach was in operation from 1954 till its closure in 1965. When hurricane Betsy caused significant damages in 1965, the beach did not reopen, and the operator of the amusement park pulled out.

The City of New Orleans has made a few attempts to reopen the beach. An effort in the early 2000s proposed demolishing most of the historic structures to rebuild the beachfront as a modern recreation facility. Selective demolition of structures occurred between 2003-2005 which included the swimming pools, Carver House restaurant, and partition walls of the existing pavilions. After hurricane Katrina, a new flood wall was constructed on the South side of the entrance tunnel. During the construction of the flood wall between 2008-2011, the drainage system for the 1939 tunnel was capped. The improvements to the site were not completed, and the site has been vacant till recently.

In 2020, community activists Sage Michael Pellet, Tricia "Blyss" Wallace, and artist Reggie Ford began cleaning up the beach in partnership with numerous volunteers. This led to the establishment of the 501(c)3 New Orleans for Lincoln Beach, spearheaded by Wallace. The City of New Orleans formed a Lincoln Beach Advisory Committee, of which Wallace is the chair. Together, a new vision for reopening the beach involves honoring its history and preserving the remaining historic structures on the site. The city completed a conditions assessment report that confirmed the remaining concrete tunnel, pathways, and shade pavilions are structurally sound and are safe to reuse. Proposed improvements include an accessible entrance to the beach, drainage improvements to the tunnel, providing narrative signage to tell the site's story, adding restrooms, and developing the parking lot across the street. New Orleans for Lincoln Beach received a Community Collaborative grant from the Louisiana State University Mass Com Department in June 2022 to host design charettes that will provide a foundation for the beach's future development; representing community input and economic development in a way that promotes and preserves the site's significant cultural history as a Black recreational refuge.

The contributing resources remaining within the property include the 1954 metal marquee signs in the parking lot area, the 1939 pedestrian access tunnel and manmade beach which date to the WPA period, the concrete walkways, two shade pavilion structures, and the waterfront platform which belonged to the large swimming pool which dates to 1954.

The 1936 blueprint for the tunnel shows the WPA Moderne style, denoted by simple geometries with clipped corners and slightly rounded edges with protrusions from the elevation that are not necessary to function but a matter of design. The man-made beach, retaining walls and central groin date back to the beach's first opening in 1941.

The shade pavilions, which date to 1954, are identical in size and located on opposite ends of the main pedestrian thoroughfare. These pavilions are one story, six bay, cast concrete structures with steel reinforcement, and have flat tar roofs. The structures are in the Streamline Moderne architectural style which was popular during the time of construction. The pavilions once housed

locker rooms and provided a shaded area for seating. The two shade pavilions remain structurally sound despite partial demolition to the locker rooms in each pavilion. The swimming pool, as it once was, is no longer reparable, but the cast concrete structural platform and many of the geometric concrete columns that once provided shade near the pool remain.

The period of significance begins when the park opened in 1941 and terminates when it closed in 1965.

Criteria Considerations (explanation, if necessary):

Lincoln Beach holds a local level of significance under Criterion A in the area of Ethnic/Black Heritage for its contribution to the overall history of public recreation and leisure in the City of New Orleans. The period of significance begins when the park first opened in 1941 and terminates when it closed in 1965. Places which were once designated for use by Black people during the Jim Crow era have a historical significance for their role in fostering the development of Black culture in New Orleans. Lincoln Beach presents a significant opportunity to preserve African American history and culture as a historic site, and residents still vividly remember, can easily recognize, and associate with the site as a former public beach and amusement park.

Narrative Statement of Significance (Provide at least one paragraph for each area of significance.)

Lincoln Beach is significant under Criterion A for Ethnic/Black Heritage as a site which is associated with events that played a significant role within the broad patterns of our history. Specifically, the history and impact of institutionalized segregation is represented in properties that were developed for use by African Americans. These properties contribute to the historic context and development of African American culture and strengthen an appreciation for African American humanity during the Jim Crow era and beyond. Black citizens had limited options for recreational leisure prior to desegregation; Lincoln Beach was a unique epicenter for Black life during its period of significance.

Lincoln Beach continues to hold a place in the memory of many New Orleans residents. Residents remember the long bus ride to the beach, taking swimming lessons, taking turns on the rides, and enjoying meals with family while watching live entertainment. The beach was a safe place where Black families could be free from public harassment. The site was first designated in 1939 and opened in 1941 after many citizens expressed a dire need for community swimming and recreation facilities for Black residents. The only public pool available to Black people in New Orleans in 1953 was the pool at the Lafon "Colored" Playground, which the *Louisiana Weekly* described as "little more than the size of a large bathtub, which children must pay to use, for even an hour or two".

Prior to the beach's opening, the best spots for public swimming and fishing were West End/Spanish Fort, Milneburg, and an area nearby called Seabrook. Seabrook was initially thought to be an appropriate location for Black swimming facilities. According to the New Orleans Levee Board in 1929, it provided "the very best

facilities for Negroes at the least expense and annoyance to the citizenship of the city". Local business owners even volunteer to fund property lighting and lifeguards to monitor swimmers. As these areas were eventually drained to make way for new exclusive developments, Black residents continued seek places to enjoy the nearby waters during hot summer months, and many lost their lives in attempting to cool off in drainage canals and the Mississippi River.

By the 1940s, it was estimated that an average of fifteen Black children drowned each summer in New Orleans (Kahrl, p. 116). Though the beach was a considerable distance from the many neighborhoods where African American residents lived in New Orleans, from its initial opening in 1941 to its closure in 1965, the beach became a popular destination where families and friends could safely learn to swim and enjoy the south shore of Lake Pontchartrain. In May of 1954, New Orleans residents gathered to celebrate the newly completed renovations to Lincoln Beach which boasted three swimming pools, a wooden roller coaster, a restaurant, arcade, and other amusement park attractions in the streamline Moderne architectural style. On the weekends, beachgoers could take swimming lessons or enjoy lunch under the pavilions in addition to hearing live music from renowned musical talents including Irma Thomas, Sam Cooke, Nat King Cole, Dinah Washington, Josephine Baker, Ernie K. Doe, Fats Domino, Ray Charles, Little Richard, The Ink Spots, Ike and Tina Turner, The Neville Brothers, "Rockie" Charles Merrick, Deacon John, Guitar Slim, and more. In April of 1967, Lincoln Beach was selected as the location for the annual Negro State Fair which highlighted education and culture.

The beach's role as a primary recreational leisure destination for African American residents and visitors diminished when swimming areas and amusement parks in New Orleans were desegregated in 1964. The park's visitation shifted to the nearby Pontchartrain Beach, which was closer to where residents lived and was considerably larger than Lincoln Beach. When Hurricane Betsy caused massive damages to the amusement park in 1965, Lincoln Beach closed to the public and has not since reopened.

Developmental History/Additional historic context information

Over time, many proposals for reopening Lincoln Beach have been made, ranging from outdoor recreation to resort casinos. In 2004, the City of New Orleans contracted with the New Orleans Land Development Corporation, who had proposed an elaborate redevelopment of the beach into a new public park and fishing pier. A number of structures were demolished including the swimming pool and restaurant, citing imminent danger of collapse as the cause for demolition. When hurricane Katrina flooded the area once again, the fate of the beach once again fell into uncertainty, as the plans for development were found unfeasible.

As the City of New Orleans continues to explore options for returning the beach to the public, residents and advocacy groups are actively developing plans that represent and honor site's significant role in Black history. The city completed a site analysis and survey of the property in 2021, which deemed that many elements on site including the significant WPA Moderne tunnel, concrete walkways, and Streamline Moderne shade pavilions are structurally sound and can be renovated. The Department of Public Works has begun the process of finding a provider to restore the significant marquee signs. The city currently has funding in place to begin restoring the beach for public access. Organizations including New Orleans for Lincoln Beach and the Preservation Resource Center have been collecting oral histories and documentation of the beach in hopes that when the city does finally reopen the site, visitors will be able to learn about its historic significance.

Site 1: Beach

The South boundary line of the property faces Hayne Boulevard. This is where the entrance to the property is located. This boundary is fenced in by a floodwall and railroad tracks. The pedestrian tunnel is the only safe means of access to the property from land.

Site 2: Beach Parking

The North boundary line of the property faces Hayne Boulevard. This is where the entrance to the property is located, denoted by two metal marquee signs. The area is currently fenced off from public access.

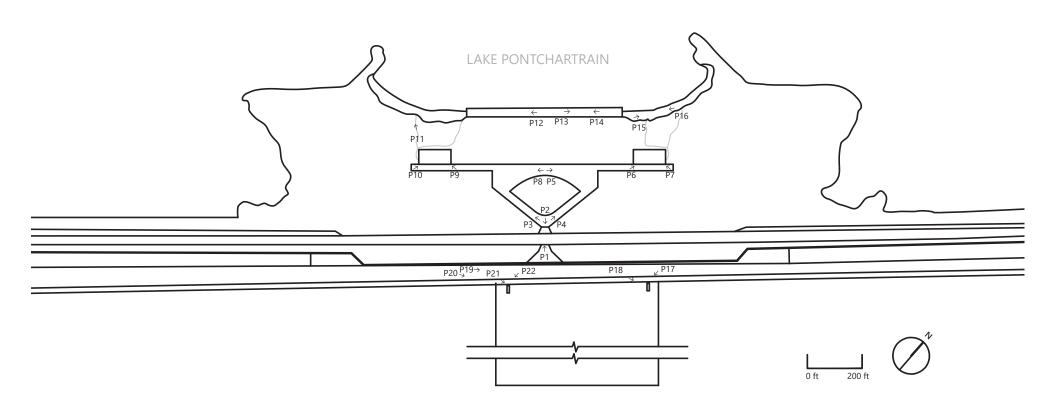

Lincoln Beach, New Orleans, LA

New Orleans city surveyor W.H. Bell first proposed the idea of fortifying the lakeshore and making the back swamps suitable for residential and recreational development.

A. Baldwin Wood, an engineer with the New Seabrook provided Orleans Sewerage and Water Board, invented a more efficient screw pump, a major breakthrough in the city's efforts to drain the swamps.

Sam Zemurray of the United Fruit Company deeds a parcel of land to the city of New Orleans.

New Orleans Levee Board purchases 2.3 acres of land from the city of New Orleans and designated the area for swimming.

Mayor Chep Morrison decided to upgrade the facilities. The site

expanded from 2.3 acres to 17 acres, and the beach was filled in with white sand. Still, the lake water remained polluted, which led to the construction of two swimming pools equal in size to those at Pontchartrain Beach. It was also outfitted with a bathhouse, a restaurant, and rides and attractions.

May 8, 1954 1964

> Pontchartrain Beach is desegregated. Attendance at Lincoln Beach declines as crowds move to Pontchartrain Beach's larger facilities.

The New Orleans and North Eastern Railroad (N.O. & N.E., also known as the Queen & Crescent and later the Southern line), which ran along the lakeshore (now Hayne Boulevard) was built to connect New Orleans to Meridian. Mississippi.

African American residents went swimming in an area known as Seabrook. The New Olreans Levee Board moved to designate this area as beach for black residents, but real estate interests and protests prevented that from happening.
